As a principle, damaged tires are to be replaced by the equivalent type. (Any exceeding costs are paid by the customer.)

After returning the rental car, visit the police, pay the fine, and show you have completed the formalities with documents such as the traffic violation notice and statement/receipt with receipt stamp through the prescribed method, at which time the money collected will be returned.
